INITIAL CONTACT

On July 10, 2009, Karen Sypher came to the Sex Crimes Squad at LMPD headquarters, seeking to initiate an investigation into her assertion that she was raped by Richard Pitino.

I took basic information from her, name, DOB, location of the alleged assault, etc. Knowing that she was under federal indictment in a case that involves her allegations of a sexual encounter with Pitino, I advised her that she would probably want to run this by her attorney before initiating a complaint. She stated that she was parting ways with Tom Clay, and that she was meeting with another attorney the following day. I advised her that someone from my office would be in contact with her. The conversation with Sypher was recorded with my knowledge. A copy of the conversation is in the file.

Due to the high-profile nature of the case, I was advised that I, as the leader of the Sex Crimes Squad, would need to handle this investigation.

I phoned Sypher later that evening and scheduled an interview with her for the following day, after she met with the attorney.

INTERVIEW WITH KAREN SYPHER

On July 11, 2009, Sypher came in for an interview. She stated that she could not afford the attorney that she met with, but that he told her that she could initiate an investigation if she wanted.

I interviewed Sypher in the interview room on the 3rd floor of LMPD headquarters. The interview was captured on DVD, and audio cassette. To gain a total appreciation of the contents of the interview, one must view the DVD, or listen to the audio tape. Summarily, during the interview, Sypher charged that Pitino raped her on two occasions. She stated that the first time

she was raped, it happened at Porcini's restaurant on Frankfort Ave. She stated that the second time, it occurred at a condominium that belonged to her husband, Tim Sypher. She and Sypher were not married at the time of the alleged sexual assault.

A transcript of the interview may be added to the file at a later date.

PHONE CONVERSATION WITH KAREN SYPHER

On July 13, 2009, I spoke with Karen Sypher by phone. The phone call was recorded with my knowledge. A disc with the conversation is included in the file. To gain a full appreciation of the contents of the conversation, one must listen to the recording.

During the call, I outlined many concerns that I have with the case. She did assert that she was sexually assaulted. I asked Sypher if she knew that Vinnie Tatum was in the restaurant with them that night at Porcini's. She said that she found that out about a year and a half after the alleged incident. I asked why she did not tell me that during our previous interview. She claimed that she did not know for sure whether or not Tatum was there, that she found that information out from her husband. I also confronted her on her timetable concerning the alleged second sexual assault. She could offer no valid explanation. We discussed other issues concerning the case. Ultimately, Sypher remained consistent in her assertion that she was sexually assaulted.

Again, one should listen to the entire audio to make a valid evaluation of the content of the conversation.

INVESTIGATION:

On July 12, 2009, spoke briefly with Special Agent David Beyer of the FBI. I spoke with him at the request of David Pence, attorney for Richard Pitino. Pence indicated that Beyer may have some information pertaining to the case that would be of some interest.

I met with Beyer at the McDonalds on the U of L campus on Floyd St. We met in the parking lot at about 1445 hours and conversed in the front seat of my personal vehicle. Beyer told me that he had interviewed Pitino in reference to a federal case against Karen Sypher regarding her extortion of Pitino. He stated that Pitino did admit to having a consensual sexual encounter with Sypher. He stated that he has interviewed several people in regards to the encounter at Porcini's restaurant. Of particular interest was his revelation that a friend of Pitino's, Vinnie Tatum, was present in the restaurant at the time of the encounter. He said that Tatum was the designated driver for Pitino that evening. He said that Tatum was out of sight of Sypher and Pitino. He also said that when interviewed by the FBI, Tatum stated that he only heard the sounds of two people that seemed to be enjoying themselves during a sexual encounter.

He also told me of past allegations that Sypher had raised against another man in which she claimed that she was raped. He also told me of details of his case pertaining to her charge of being untruthful to a federal agent. The case is somewhat intertwined with this investigation since the charge stemmed from her assertion that she did not know about phone calls that were placed to Pitino in an attempt to extort money from him, nor did she know who placed the calls. The extortion involved Sypher not going public with the information concerning the alleged sexual assault, and subsequent abortion. He told me this due to its importance in determining Sypher's credibility.

We exchanged business cards, and Beyer offered any assistance that I would need from him, as is customary when separate agencies meet.

INVESTIGATION:

On July 12, 2009, I interviewed Richard A. Pitino in the presence of his attorney, David Pence. The interview took place in Pitino's office at the Yum! Center on the campus of the University of Louisville. I advised Pitino that Karen Sypher had accused him of raping her on two separate occasions; once at Porcini's restaurant, and the other at Tim Sypher's condominium. I asked Pitino if he raped Sypher. He replied that he did not. I asked him to describe to me the events that happened on the evening that he met Sypher at Porcini's. He said that it was August 1, 2003, and that he was there celebrating the hiring of Reggie Theus. He added that Vinnie Tatum was also present, as he was the designated driver for the evening. He said that Sypher walked up and asked him if he would call her son and encourage him regarding sports and school. He stated that he complied with her request. He said that she left the restaurant, and then came back later, close to closing time. He said that around the time that she returned, the restaurant began to clear out to the point that the only persons present were him, Sypher, Tatum, Tim Coury, and Melissa Brent. Coury is the owner of the restaurant, and Brent was a bartender that evening. He added that he was unaware until recently that Tatum was still at the restaurant, stating that he found that out during the course of the events leading up to Karen Sypher's federal indictment for Extortion. He added later that Sypher knew that Tatum was there. He stated that Tatum had lain down out of site of him and Sypher. He stated that Tatum's reason for remaining in the restaurant was because of his duties as Pitino's designated driver. Pitino said that he had had too much to drink and could not drive home. Eventually, Coury and Brent left, leaving Pitino, Sypher, and Tatum in the restaurant. He said that Sypher started coming on to him pretty strong and that they had sex. He said that she asked him if he had a condom, and that he advised her that he did not. She told him that he should pull out because she had just gotten out of a relationship, and was not on birth control. He said that she drove him home from Porcini's, and that she was driving him crazy asking him for basketball tickets. He said that when she dropped him off, he gave her his card, and told her to call about getting tickets.

He said that about two weeks later, she called and told him that she was pregnant. She told him that she is always on time with her menstrual period. He said that she told him that she needed to meet with him to discuss the matter, and that he told her that they would have to meet

condominium. Tim met her somewhere, and she followed him to the condo. He said that this meeting occurred about 2 1/2 to 3 weeks after the August 1 encounter, and that it was definitely less than one month later. He said that she asked for a drink and that he gave her a glass of wine. He said that he asked Tim to go upstairs, but for him not to watch television or anything, just to stay alert. He said that she told him that she was pregnant. He said that he asked her if she was sure that it was his, and that she seemed quite miffed at the question. He said that he explained that he was married with five kids, and that she had four kids, and that he didn't know what he wanted to do about the situation. He said that if she chose to have the child that he would require a blood test to determine for certain whether or not the child was his. She told him that she was going to have an abortion, and stated that she did not have health insurance. He asked how much it would cost. She gave him the figure of \$3000, which he gave to her. He said that she then went to counseling, and then had an abortion. I asked him if there was any sort of sexual encounter at the condo. He denied that there was. I asked him if there was any other encounter besides the one at Porcini's he stated that there was not. He added that following the events of that month in 2003, Sypher married into the U of L family. He said that they often attended the same parties, that they tailgated at football games together, made trips with the basketball team together, and that Sypher even went to his niece's shower. He said that amongst all of those social occasions where they were with each other, that she never displayed any strange behavior.

I asked him if there were any other actions that took place between Sypher and anyone else at Porcini's that evening. He said that he didn't see anything take place, but that I should ask Tatum, and Courey. I asked if there was anything else that he would like to add that had not been covered. He said that she had been picked up at a bar before coming to Porcini's, then drank more once she arrived. He said that after she left, then returned, she drank even more. He did add that she did not seem too intoxicated to drive him home, that she was not weaving all over the road, or anything of that nature. His attorney also shared that Pitino had taken a polygraph examination on 07/12/2009. The test was administered by retired FBI Agent Carl Christiansen. I viewed the report that Pence advised me was prepared by the examiner. Two questions in particular were the focus of the examination. One was the question of whether or not he forced that woman (Sypher) to have sexual intercourse with him. He answered, "No." The second, a similar question, was to the affect of in 2003, did he force that woman to have sex. Again, Pitino's answer was, "No." The results of the examination as was evaluated by Christiansen were "NDI", which means "no deception indicated".

Additionally, Pence showed me a copy of Pitino's calendar from 2003, in which it indicated that Pitino was in Pebble Beach on August 28 & 29, 2003. He showed me this in response to my revelation that Sypher had claimed that the second alleged sexual assault took place somewhere around August 26-29, 2003.

It should be noted that Karen Sypher married Tim Sypher after these alleged incidents took place.
